## Judicial Training & Research Institute, U.P., Lucknow



Brief Report regarding Faculty Development Programme (ToT-3) regarding Adjudicating Terrorism Cases held at Judicial Training & Research Institute, UP, Lucknow on March 25-26, 2023.

The workshop held at Judicial Training & Research Institute, UP, Lucknow on March 25-26, 2023 was third and final Faculty Development Programme before the working groups pilot workshop for District & Sessions Court Judges regarding Adjudication of Terrorism Cases conducted under the directions of National Judicial Academy, Bhopal by Federal Judicial Centre and CEELI Institute.

The major objectives of this programme were to refine and finalize the curriculum. The other objectives were to discuss the elements of effective presentation and facilitation, identifying the reading and other materials to be distributed and preparing participants to teach a 30 minutes segment of their workshop session.

On Sunday, March 25, 2023, the programme commenced at 09.30 A.M., the programme was inaugurated by Hon'ble Mr. Justice Devendra Kumar Upadhyaya, Judge, Allahabad High Court, Lucknow Bench, Lucknow and Chairperson, Supervisory Committee, JTRI. In His Lordship's inaugural address, emphasize was laid on the efficiency of Training of Trainers regarding Adjudication of Terrorism Cases.

The opening remarks were made by Sri Vinod Singh Rawat, Director, Judicial Training & Research Institute, UP, Lucknow and Mr. Cristobal Diaz, Director of Outreach and Development, CEELI Institute in the gracious presence of Hon'ble Anthony Porcelli, Magistrate Judge, US Court for the Middle District of Florida and Mr. Jim Chance, Senior Judicial Education Attorney, Federal Judicial Centre, USA. The participating Judges were also present in the inaugural session. The inaugural session was compeered by Sri Pushpender Singh, ADJ, Lucknow/OSD, JTRI. The inaugural session was followed by group photograph.

During the two days faculty development programme, the judicial educators emphasized on the process of preparing for a workshop keeping in mind the original educational objectives. Mr. Jim Chance communicated that great teachers,

like great Judges, are not born. They are made. During the session, he laid down the important tips for preparing and delivering effective presentations.

Each participant were given the task to present their segment in 30 minutes of their workshop's session, which must include the opening statement, interactive components and the activities of their workshop session. The PPT presentation skills were enhanced by Mr. Cristobal Diaz sharing some important aspects to be introduced in power point presentations. The judicial educating team interacted regarding the careful presentation of session outlines and conservative selection of additional readings. They also facilitated the participants to develop tailored handouts such as 'quick guides' or 'check-list' that distill the essential points of their sessions.

At last, the final modifications and preparations were made to create a tentative schedule and curriculum for the upcoming pilot workshop. The closing remarks were made by Hon'ble Judge Anthony Porcelli, Mr. Jim Chance and Cristobal Diaz. Concluding the programme, Judicial Training & Research Institute, U.P., Lucknow honoured the faculty and participating Judges from different part of country.
