VISITING SCHOLAR PROGRAM

12TH TO 30TH JUNE 2023

National Judicial Academy is engaged in a collaboration with the Federal Judicial Centre, Washington D.C. and the CEELI Institute, Prague for promoting common areas of training for judges. The objective of this collaboration has been to create judicial expertise in specialized areas of law to enable effective adjudication of cases in these areas of law, and enable sharing of best practices and exchange of domain knowledge. In furtherance of this collaboration, the CEELI Institute invited two representatives from India as Visiting Scholars —

- ➤ Hon'ble Mr. Justice Joymalya Bagchi, Judge, High Court of Calcutta, and
- ➤ Ms. Shruti Jane Eusebius, Research Fellow, National Judicial Academy

The Visiting Scholars were hosted by Bolch Judicial Institute at Duke University Law School, Durham, North Carolina and the Federal Judicial Center, Washington D.C. The focus of the three-week Visiting Scholar program was the conceptualisation and development of a counterterrorism adjudication benchbook for judges that can be disseminated widely across the judiciary in India. The Visiting Scholars spent three weeks in USA meeting with judges and domain experts with experience in terrorism law and adjudication, as well as visiting judicial education institutes to discuss and exchange views on issues involved in adjudicating terrorism cases. Thereafter, the Visiting Scholars conceptualised a structure and approach for creating a benchbook on adjudicating terrorism cases.

WEEK 1

12th to 18th June 2023

Durham, North Carolina

The Visiting Scholars spent the week at the Bolch Judicial Institute at Duke University Law School, Durham, North Carolina. During this week, the Visiting Scholars interacted with the faculty at Duke University Law School viz. Paul Grimm, Sara Sun Beale, Brandon Garrett, Jonathan Petkun, Jack Knight, Shane Stansbury and Oleg Kobelev. The discussions in these interactions covered various aspects of terrorism law, case management and pendency, judicial decision making, prosecution of terrorism and evidentiary issues. The Visiting Scholars also audited the Judicial LLM course at Bolch Judicial Institute and interacted with the judges who

were attending the course. The Visiting Scholars also visited the US District Court, John Hervey Wheeler Courthouse at Durham and interacted with Judge Joe L. Webster.

WEEKS 2 & 3

19th to 30th June 2023

Washington D.C.

The visiting scholars spent two weeks in Washington, D.C. at the U.S. Federal Judicial Center. During the two weeks at the FJC, the scholars visited the courts at Washington D.C. and Virginia and interacted with judges who have dealt extensively with terrorism cases –
