## <u>REPORT ON</u> <u>NATIONAL ORIENTATION PROGRAMME FOR NEWLY APPOINTED</u> <u>CIVIL JUDGES</u> <u>(JUNIOR DIVISION) P-841</u> 12<sup>th</sup> –18<sup>th</sup> September, 2014

The 07 days National Orientation Programme for Newly Appointed Civil Judges (Jr. Division), second one in the series of 06 programmes, was held at National Judicial Academy from Friday 12<sup>th</sup> September to Thursday 18<sup>th</sup> September 2014. Around fifty six Judges from across the country participated in this programme.

While the higher judiciary is the face of the national judicial system in international circles, district judiciary is face of justice and the judiciary for the common man of this country. It is the judges at the lowest tier in the judicial hierarchy who are the backbone of the judicial system and have to bear the burden of major bulk of litigation.

This programme was aimed at capacity-building of judicial officers at the lowest rung of judiciary - civil judges (junior division). Catching them young, a programme for junior division judges provides an opportunity to young judicial officers to share experiences and views with judges from across the country in the beginning of their careers. This programme aimed to facilitate better appreciation of the role and responsibilities of judicial officers as members of independent judiciary in a constitutional democracy.
