National Judicial Data Grid (NJDG)

- National Judicial Data Grid (NJDG) is the repository/mine of case data available on public platform
- Considered as innovation by world bank in ease of doing business
- Provides monitoring of pendency and disposal of cases
- Several dashboards/reports to monitor cases based on various parameters
- High court management can use NJDG to its full potential to manage the courts under its superintendence
- Certain features are available on public interface of NJDG while more features are available on INTRANET NJDG – provided to the High Courts and District Courts to assist in management and decision making
- Provides facility to gain insight of pendency and disposal of the entire state or any particular location at finger tips



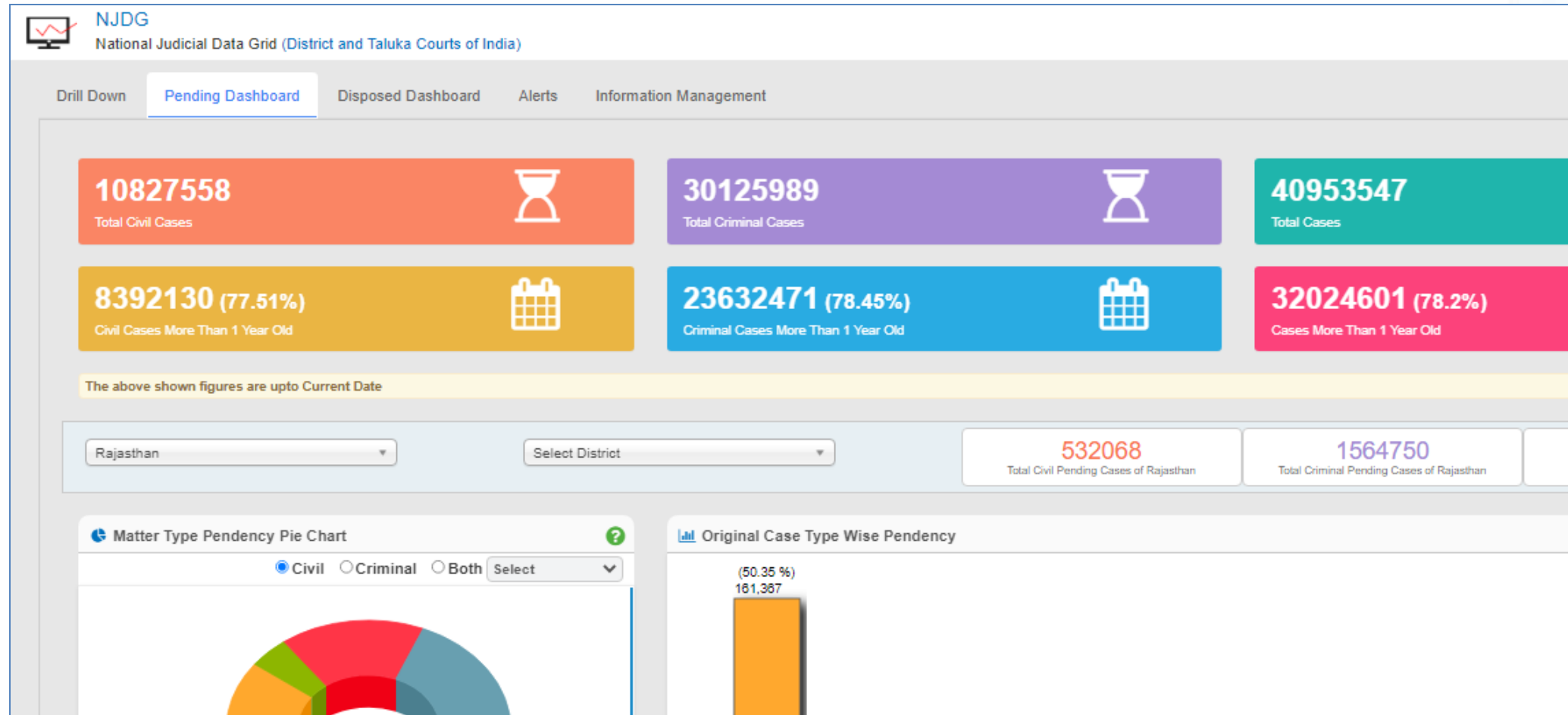



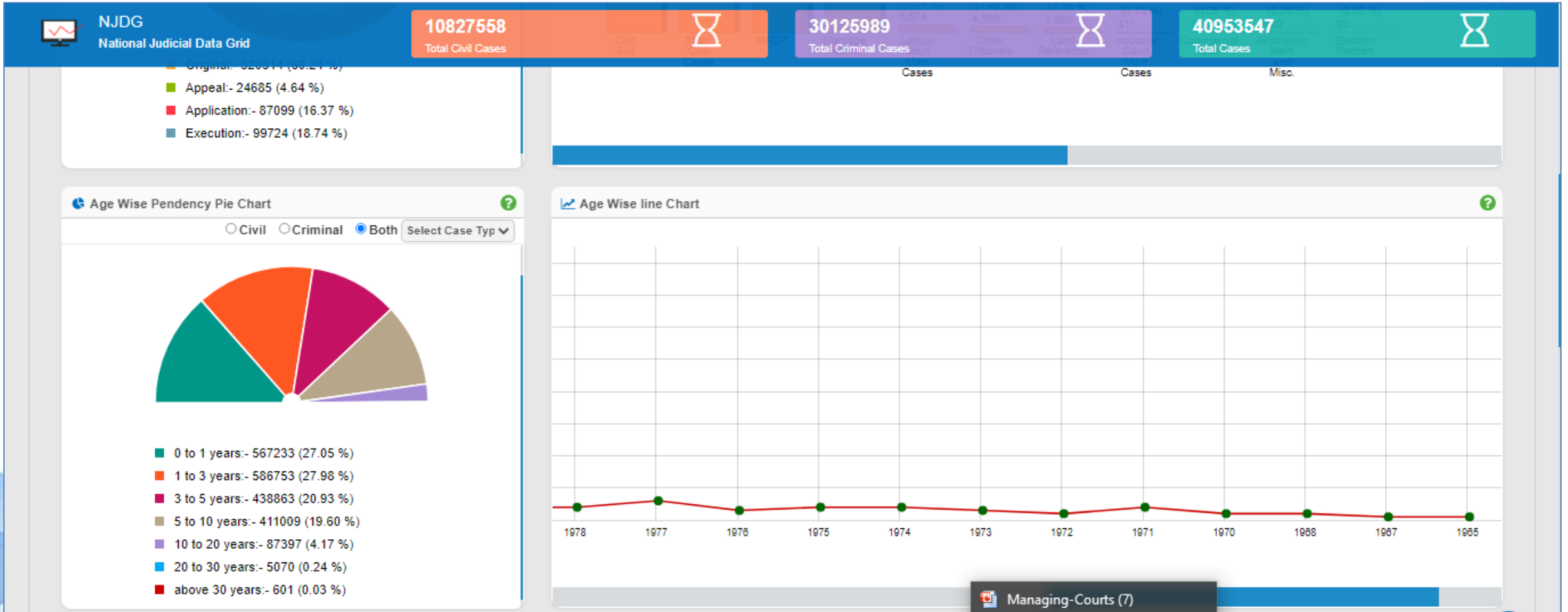

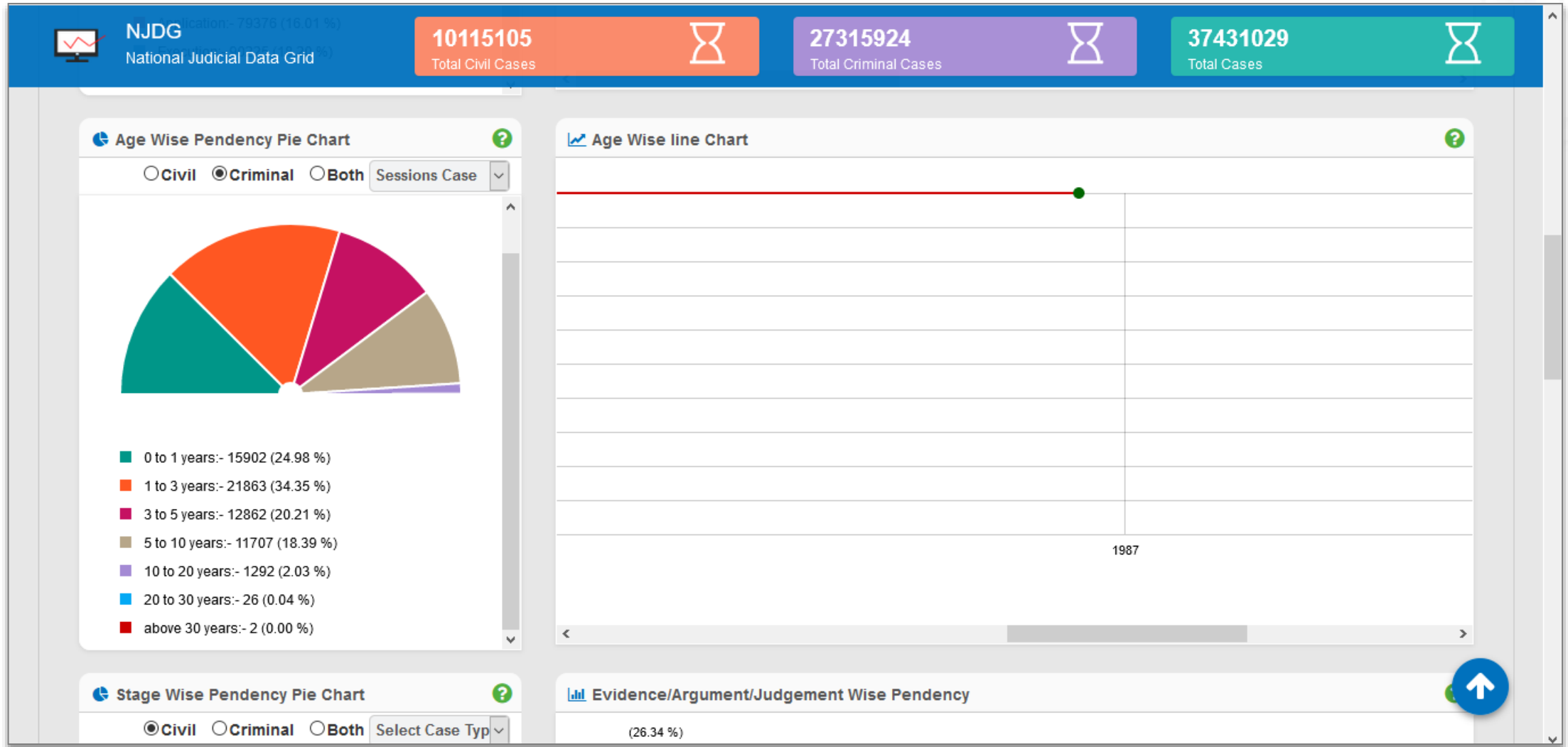


