AIR 1943 LAH 14

"A lawyer should always conduct himself properly in a court of law and exert his least at all times to maintain the dignity of the Court but the Court has also a reciprocal duty to perform and should not only be discourteous to a lawyer but also should try to maintain the lawyer's respect in the eyes of his clients and the general public with whom he has to deal in his professional capacity."

BRAHMA PRAKASH SHARMA & Others VS STATE OF UTTAR PRADESH

AIR 1954 SC 10

"The question arises whether it can be held to amount to contempt of court. To answer this question, we have to see whether it is in any way calculated to interfere with the due administration of justice in these courts, or, in other words, whether such statement is likely to give rise to an apprehension in the minds of litigants as to the ability of the two judicial officers to deal properly with cases coming before them, or even to embarrass the officers themselves in the discharge of their duties."

R. MUTHUKRISHNAN VS REGISTRAR GENERAL, MADRAS HIGH COURT
